교과목개요

이 과목은 한반도의 우리 삶에 커다란 영향을 미치고 있는 세계정치를 본격적으로 이해하려는 노력이 1차세계대전 이래 역사적 그리고 지역적으로 어떻게 전개되어 왔는가를 추적한다. 따라서 현대 국제정치학의 유럽적 탄생, 미국으로의 중심이동, 동아시아를 비롯한 전세계적 전파와 변용 문제를 다루게 될 것이다. 이러한 시도는 현대 세계정치학의 국제정치적 성격을 제대로 이해하려는 노력이며, 더 나아가서 우리에게 필요한 한국, 아태, 그리고 세계정치학을 모색하는 첫걸음이다.
